

So far, there has been neither public nor jurisprudential discussion of these extensive changes. A debate in the Bundestag has not taken place either. Therefore, we as citizens are called upon with our own initiative.

We citizens have the right to informed consent, medical self-determination and personal sovereignty.

We must not allow a democratically non-legitimised health authority to impose such massive interventions in our lives and health.

We must protect our fundamental rights and our freedom.

"Who will negotiate and sign this treaty on behalf of Germany?"

"How are these plans of the WHO compatible with our Basic Law? Should pharmaceutical companies and foundations determine our lives and our health and no longer we ourselves?"

DO YOU WANT A TOTALITARIAN HEALTH DICTATORSHIP? IF NOT, GET ACTIVE AND ACT NOW!

The World Health Organisation (WHO) is an unelected global health authority that is largely financed by private foundations and pharmaceutical companies, but which wants the 194 member states to grant it far-reaching, totalitarian powers without the people concerned being informed.

Negotiations are currently underway at WHO on a **global pandemic treaty that will** govern both the governmental response to pandemics and the revision of the **international health regulations**, the legal framework for public health emergencies, preparedness and response.

The **pandemic treaty** and the amendments to the **International Health Regulations** will be presented for adoption at the 77th World Health Assembly in May 2024.

Amendments to the International Health Regulations require a **simple majority**. Subsequently, the regulations enter into force for all states within 12 months. The pandemic treaty requires a 2/3 majority to be adopted. Thereafter, each WHO member state can sign and ratify the treaty in accordance with its national law.

The results of these negotiations will affect the lives, health and human rights of people around the world.

The proposed amendments give unique "emergency" powers to WHO and thus to the Director-General.

The 10 most important reasons against changing the international HEALTH regulations



" **CHANGE FROM ADVISORY TO BINDING**

Change the nature of the World Health Organisation from a consultative organisation that only makes recommendations to a governing body whose pronouncements are legally binding.

(Article 1 and Article 42)

" **POTENTIAL RATHER THAN ACTUAL EMERGENCIES**

The scope of the International Health Regulations is greatly expanded to include scenarios that only have the potential to affect public health. (Article 2)

" **DISRESPECT FOR DIGNITY, HUMAN RIGHTS AND FREEDOMS**

Respect for human dignity, human rights and fundamental freedoms shall be abolished. (Article 3)

" **DISTRIBUTION PLAN**

The Director-General of WHO is to be given control over the means of production through an "allocation plan for health products" in order to oblige the States Parties to supply products for pandemic control as prescribed. (Article 13A)

" **COMPULSORY MEDICAL TREATMENTS**

WHO is given the authority to require medical examinations, proof of prophylaxis, proof of vaccine and the implementation of contact tracing, quarantine and medical treatment. (Article 18)

" **GLOBAL HEALTH CERTIFICATES**

Introduction of a system of global health certificates in digital or paper form, including examination certificates, vaccination certificates, prophylaxis certificates, convalescence certificates, travellers' whereabouts forms and a declaration of the traveller's state of health. (Articles 18, 23, 24, 27, 28, 31, 35, 36 and 44 and Annexes 6 and 8)

" **LOSS OF SOVEREIGNTY**

Would empower the Emergency Committee to override decisions of sovereign states on health measures and make the Emergency Committee's decisions binding. (Article 43)

" **INCALCULABLE COSTS:**

WHO grants itself the right to distribute billions of dollars without accountability to the hospital-emergency pharmaceutical-industrial complex. (Article 44A)

" **CENSORSHIP**

Significant expansion of the World Health Organisation's ability to censor what the WHO considers to be misinformation and disinformation. (Appendix 1, page 36)

" **COMMITMENTS TO COOPERATION:**

Creates an obligation to build, provide and maintain IHR (International Health Regulations) infrastructures at points of entry. (Annex 10)
